### **What Will You Do?**

As the Regional Organizing Director, you will supervise a team of field organizers to recruit, train, and supervise volunteers. Amongst other tasks, these volunteers will conduct direct voter contact to targeted voters in your assigned region. You will also serve as a liaison for your region with the Voter Protection Director, GOTV Director and will assist the Organizing Director and Campaign Director with political relationship management in your region.

- Lead a team of field organizers to recruit, train, and supervise volunteers
- Hold field organizers accountable to metric-based goals for volunteer recruitment and direct voter contact
- Develop and execute a regional organizing plan consistent with the statewide organizing plan that is tailored to the needs of communities within your region
- Develop and supervise political relationships with key stakeholders in your region
- Cultivate a positive team culture centered around respect, accountability, and collaboration
- Other duties as assigned

The ideal candidate will be a highly motivated and passionate promoter of Democratic values and have experience organizing volunteer programs on Democratic campaigns. You will thrive in a fast-paced, high-pressure, data and metric-driven environment.

## **Qualifications:**

- At least two cycles of statewide or competitive campaign experience as a field organizer or fellow;
- Previous management experience, preferably in a political campaign setting
- Excellent written and verbal communications skills;
- Ability to work in a fast-paced, high-pressure environment;
- Sense of humor and solutions-oriented attitude;
- Knowledge of Votebuilder, Microsoft Office Suite, and other campaign technology preferred;
- Ability to work long and irregular hours in a metric-driven environment;
- Ability to be flexible under pressure and meet tight deadlines;

This position will be based in an assigned region in the state of Illinois. We ask that candidates relocate to their region (if not already residing there). Applicants must have the ability to travel throughout their region regularly. Applicants must have a valid driver's license, and a reliable mode of transportation.
