	Voting by Mail
Can I vote by mail?	Yes, <u>any voter</u> (link to page with vote-by-mail FAQ) can vote by mail. Voters can choose either to vote by mail in the next election only or to get a mail ballot for every election moving forward ("Permanent Vote by Mail Roster").
How do I vote by mail?	Voters can request a vote by mail ballot from their election authority, in-person, by mail, or online. By default, the forms will opt voters into VBM for the next election only. Voters who want to become permanent mail voters should make sure to complete the appropriate form Application forms vary, so consult the <u>BOE Mail</u> <u>Ballot Application Finder</u>
How do I complete my vote by mail ballot?	Illinois does not post instructions online. Carefully review the instructions enclosed with your ballot. Be sure to provide your signature on the mail ballot certification.
How do I vote if I am in a healthcare facility?	Any qualified voter that has been admitted to a healthcare facility (hospital, nursing home, or rehabilitation center) not more than 14 days before the election or, if released, is expected to be homebound on the day of the election and unable to travel to the

	<ul> <li>polling place, shall be entitled to personal delivery of an emergency ballot.</li> <li>1. Voter must obtain an Application for Physically Incapacitated ElectorBallot for Qualified Voter Admitted to Hospital, Nursing Home, or Rehabilitation Center. The application can be obtained from the election authority (county clerk or board of election commissioners, depending on where the voter is registered to vote).</li> <li>2. Voter must complete their application and their physician must complete and sign the Certificate of Attending Physician section of the application.</li> <li>3. After the form is completed and signed by the voter and their physician, a registered voter from the voter's precinct or any legal relative can then hand deliver the application to the election authority's office.</li> <li>4. After signing an affidavit, the precinct voter or legal relative may personally hand deliver the ballot to the voter at the healthcare facility they have been admitted to.</li> <li>5. Once the voter receives the ballot, they will vote the ballot in secret and complete the certification on the ballot return envelope.</li> <li>6. After depositing their voted ballot in the return envelope, the voter will securely seal the envelope and give the envelope to the precinct voter or to the legal relative. The ballot must be delivered back to the election authority before 7:00 p.m. on Election Day.<sup>4</sup></li> </ul>
How can I "cure" any issues with my ballot?	If a signature is rejected, voters must be notified before the close of the provisional counting period and have until 14 days after the election to appear before election officials and present evidence in support of their ballot. <sup>5</sup>

What if I requested a Vote-by-Mail ballot but I want to vote in person on Election Day?	If you have already received your mail ballot, take it with you to an early voting site or your polling place on Election Day and surrender it to an election judge. Your mail ballot will be voided, and you will receive a regular ballot. If you have not yet received your mail ballot, you will be asked to
	sign an affidavit certifying you have not received your ballot. You will then be issued a regular ballot.
	If you received your mail ballot but lost it, you may sign an affidavit certifying you have not yet voted in this election. You will then be issued a provisional ballot. If your mail ballot arrives after you have voted but on or before Election Day, you must discard the mail ballot. Do not attempt to vote your mail ballot after you have voted in person. Doing so is a Class 3 felony. (And because voting systems will not allow more than one vote per voter, your mail ballot will be rejected.)

How do I check the status of my vote-by-mail ballot?	Illinois doesn't have a statewide tracking system. Contact your county elections office here
Military/Overseas voting	<ul> <li>Illinois citizens serving in the U.S. armed forces may register using one of the following methods (see link to military guidelines PDF):</li> <li>1. Illinois Military and Overseas Voter Empowerment (MOVE)-enables you to set up a MOVE account to register to vote and request vote-by-mail ballots for upcoming federal elections. This was designed to ease the burden of these voters. (This is not applicable for municipal elections)</li> <li>2. Federal Voting Assistance Program (FVAP)- provides the Federal Postcard Application to members of the U.S. armed forces to cast a vote by mail ballot and register to vote. This may be submitted by mail, fax, or email.</li> <li>3. Special State Write-In Ballot- LAST RESORT OPTION – if time is running out, you can complete a Special State Write-In ballot and mail it in to local election officials.</li> </ul>

	Provisional Ballots
What should I do if a poll worker tells me to use a provisional ballot?	<ul> <li>A voter must cast a provisional ballot if:</li> <li>The voter's name does not appear on the official list of eligible voters for the precinct in which the person seeks to vote and the person has refused to register;</li> <li>The voter's voting status has been challenged and a majority of the judges uphold the challenge;</li> <li>The voter did not provide identification when registering by mail and still cannot provide ID on Election Day;</li> <li>A court order extends the time for closing the polls, and the voter votes during this extended time period;</li> <li>The voter's name appears on the list of voters who voted during the early voting period, but the voter claims not to have voted during the early voting a vote by mail ballot, but failed to return it to the election authority (or election Judges); or</li> <li>The voter attempted to register to vote on Election Day, but failed to provide the necessary documentation.<sup>6</sup></li> </ul>

<ul> <li>Each provisional voter should be provided written instructions on how to follow up after Election Day.</li> <li>The provisional voter may submit additional information to the election authority. (If a voter needed to present ID but did not have it at the time they could present it after voting on a provisional ballot.)</li> <li>The additional information must be received by the election authority no later than the close of business on the Tuesday following the election.</li> <li>The election authority has 14 days after the election to determine voter eligibility, and thus if the ballot should be counted.<sup>7</sup></li> </ul>	
Voter Machine Questions	
If there are any issues with the voting machines, including issues with the scanner, please notify the Election Judge.	
Voter Challenge/Electioneering	
A voter's right to vote may be challenged by election judges, other registered voters in the voting site, or pollwatchers with valid credentials. If a challenge is sustained by a majority of election judges, you will be asked to cast a provisional ballot. Each provisional voter should be provided written instructions on how to submit additional materials, if necessary, to the election authority, and how, after the

Electioneering/ People campaigning or hanging around polling location/Can they approach me?	Electioneering is prohibited within 100 feet of polling places. Prohibited activities include wearing campaign buttons, badges, t-shirts, or hats asking voters to vote a particular way. <sup>9</sup>
Are firearms allowed at a polling place on Election Day?	Illinois has no specific statutory gun possession prohibitions in or at polling places. However, Illinois generally prohibits the possession of a firearm in or on the real property of a public park, courthouse, any conveyance owned, leased, or contracted by a public transportation agency, or on any public way within 1,000 feet of the real property comprising any school, courthouse or public transportation facility. <sup>10</sup>
	Voting with a Disability
Accessible Voting for Persons with Disabilities	All polling places are required to accomodate voters with disabilities under both federal law (ADA) and state law (10 ILCS 5/11-4.2). However, if a voter is concerned about accommodation of their individual disability at a specific polling place, they should reach out to their local election administrator to confirm that a site suits their needs.
	Disabled persons who want to request curbside voting should call their <u>local election office</u> in advance to request. Generally the election authorities provide curbside voting if requested in advance. Some county websites (find using <u>link</u> ) have information about curbside voting.

	Voters should also be aware of the availability of no-excuse mail voting, which may be a more convenient option for them to vote, depending on their specific needs.

Can I receive assistance at the booth while voting?	<ul> <li>Only those voters who need assistance may be given assistance.</li> <li>Illinois law provides that the following persons may receive assistance (follow link to PDF on voting assistance): <ul> <li>Persons with disabilities or visually impaired voters;</li> <li>Those voters who cannot read or write the English language.</li> </ul> </li> <li>All voters needing assistance must be registered to vote. Voters may get assistance from a person of their choosing, except that the person assisting may not be an officer or agent of the voter's employer or union. If the voter who needs assistance does not specify a particular person to assist them in voting, then the voter can be assisted by two election judges, one from each political party. An officer or agent of the voter's request and only after the voter who requests assistance.</li> </ul> Assistance can only be given upon the voter's request and only after the voter completes the appropriate affidavit. In every instance of assistance, both the voter receiving the assistance and the person(s) giving the assistance must sign the affidavit. Also, the voter's Application for Ballot must be marked by an election judge to
What if I am admitted to the hospital before election day?	show that the voter requested assistance. Any qualified voter who has been admitted to a healthcare facility (hospital, nursing home, or rehabilitation center) not more than 14 days before the election or, if released, is expected to be homebound on the day of the election and unable to travel to the polling place, shall be entitled to personal delivery of a ballot. <sup>11</sup>
	Language Issues
Can I get assistance voting if I cannot read English?	Yes. A person of the voter's choosing, except for an officer or agent of the voter's employer or union, may assist the voter. If the voter who needs assistance does not specify a particular person to assist them in voting, then the voter can be assisted by two election judges, one from each political party. An officer or agent of the voter's employer or union may not assist a voter who requests assistance.

	Trans Voting Issues
Do I need to re-register if I have changed my name?	If you changed your name, you should re-register with your election authority, and may do so up to and on election day itself using grace period registration.
	Student/Youth Voting
Student voting	Students have a choice about where to register to vote.
	Students attending college may register at their campus address or choose to remain registered or register at their permanent or home address.
Can I pre-register to vote?	No. You must be 18 years old to vote in a Consolidated or General Election or 17 years of age to vote in a Consolidated Primary or General Primary if the individual will be 18 by the time of the Consolidated or General Election.
	Felony disenfranchisement
If I have been convicted of a crime can I vote?	You have the right to vote as long as you are not currently incarcerated because of a conviction for a felony. If you are on parole, probation, or have completed your sentence, you have the right to vote. You will need to re-register to vote once you have been released. Refer to instructions for voter registration.
	Miscellaneous
Can my children go with me when I vote?	Minor children are permitted to accompany their parents or guardians into the voting booth. <sup>12</sup>
Ballot Selfies	Not allowed. Photography is not allowed at the polling place. <sup>13</sup>
